

**This sample of a religious vaccine exemption has been provided to us by Jessica Kennel, OKHPR Senate District Captain and Ordained Minister.**

To whom it may concern,

This letter serves to provide verification that EMPLOYEE NAME fellowships whole-heartedly in the Christian community and pursues a devout path of faith. In accordance with the Christian faith, EMPLOYEE NAME adheres to the belief that every life is sacred, and our bodies are temples of God, and as such should be kept pure and in His image. Therefore, we are compelled by our beliefs to vehemently refuse and ultimately be exempted from any man made medical treatment, injection, vaccine or inoculation containing or being created with aborted fetal cells or animal organs, parts, or DNA, which would result in placing these excipients, or foreign man made substances and/or toxins into the body and/or blood stream, contaminating our bodies and violating our deeply and sincerely held religious beliefs. The currently available vaccines for covid-19 are manufactured with or tested on aborted fetal cell lines. Both Pfizer and Moderna use the HEK-293 cell line for the confirmation stages of development. The Johnson and Johnson vaccine used PER.C6 in both the manufacturing and testing phases of development. This is directly in violation of our deeply held belief that all life is sacred and as such, we cannot be compelled to receive any inoculation or medical procedures that are derived from or support abortion in any way. Using a product that uses fetal cells in any part of the manufacturing process is against our deeply held religious beliefs, and compelling us to receive any of the current vaccines available for use for covid-19, would be against our religion. As EMPLOYEE NAME understanding and development of faith continues, the pursuit becomes more devout in nature. As we learn, we grow, and EMPLOYEE NAME is pursuing this faith more fervently. As EMPLOYEE NAME faith deepens, so do the practices of worship and faith. EMPLOYEE NAME has come to understand that any vaccines/inoculations/medical treatments containing animal DNA or blood are also a violation of keeping our bodies pure and in His image, and as such cannot be compelled to receive any of these products. For these reasons, EMPLOYEE NAME is respectfully refusing. This is pursuant to our right to freedom from religious discrimination per title VII of the Civil Rights Act of 1964, and to our right to refuse any and all vaccinations or medical procedures on the grounds of religion, in accordance with our faith:
